Coastal Carolina University has received approval to establish the Bachelor of Science in Nursing (B.S.N.) degree program effective Fall 2024 from the South Carolina Commission on Higher Education (SCCHE) on June 6, 2023 and the South Carolina Board of Nursing (SCBON) on January 25, 2024.

The Bachelor of Science in Nursing degree program consists of 25-49% new content not previously offered by the institution at the baccalaureate level.

The method of delivery to be added:

Face-to-face instruction

The intended implementation date:

August 1, 2024

The Bachelor of Science in Nursing (B.S.N.) degree program will prepare nurses for a variety of entry-level nursing roles in the healthcare system and healthcare organizations. Many healthcare systems and employers are seeking out nurses with a Bachelor of Science in Nursing to improve safety and help prepare for future healthcare challenges. This program will provide Coastal Carolina University students a 4-year bachelor of science program that prepares them to take the National Council Licensure Examination (NCLEX) to become a registered nurse. There is strong evidence that shows a B.S.N. provides graduates the skills and education they need to grow as clinicians and make a significant impact in the nursing profession. The program builds on documented student demand, local and regional need, and existing programs and faculty in the new Conway Medical Center College of Health and Human Performance. Examples of existing programs include a Bachelor of Science in Nursing (R.N. to B.S.N.) completion program and the Bachelor of Science in Health Sciences.


The degree incorporates highly experiential and clinical learning practices to enhance academic instruction by experienced and professionally-active faculty. Furthermore, the program will foster academic excellence through a teacher-scholar model with enhanced and supported effective teaching and scholarly/creative endeavors, expanded learning opportunities, and engagement of all campus community members. The resulting student experiences and opportunities promote student excellence. It is highly probable that the new B.S.N. will also be attractive to out-of-state students thereby aligning with Coastal Carolina University's commitment to building undergraduate degree programs of national or regional significance. This degree program will directly support the University mission to "develop students who are both knowledgeable in their chosen fields and prepared to be productive, responsible, healthy citizens with a global perspective" and support "faculty research, creative activities, and expert collaboration in the community, state, nation and world".

The B.S.N. degree program will require eight new courses. New financial resources are needed to renovate current space, purchase equipment, and to hire one new full-time faculty member. The new full-time faculty member will be hired in order to compile with South Carolina state law *Nurse Practice Act* that states the majority of nursing faculty must be full-time and the full-time equivalent of clinical instructors shall not exceed 30% of the filled full-time faculty positions. The current nursing lab will be renovated to accommodate a 3-bed clinical/simulation space that will include simulation equipment. No new library/learning resources are needed to support the new degree program.

Board Decision Letter

In accordance with South Carolina Code of State Regulations, Chapter 91- Section 5: *Procedure for Survey and Initial Approval of Nursing Programs*, Coastal Carolina University, Baccalaureate Degree in Nursing (BSN) Program requested to appear in front of the Board seeking Initial Approval status. This matter came before the State Board of Nursing for South Carolina on January 25th, 2024.

The Board deliberated the request with a quorum present. After careful consideration of the materials submitted and the presentation, as well as recommendation by the Advisory Committee on Nursing Education, the **Coastal Carolina University, Baccalaureate Degree in Nursing (BSN) Program is granted Initial Board Approval, effective January 25th, 2024.**

Initial approval means the official status granted to a newly established nursing program that shows evidence of meeting the Board's legal and educational requirements, this status continues in effect until the results of the National Council Licensure Examination (NCLEX) for the first graduating class are published and a survey has been completed.

A nursing program must make application for full approval within six months following the taking of the NCLEX by the first graduating class. A self-evaluation report will be submitted. A survey shall be conducted and a written report prepared for the Board to determine the approval status of the program.
